Seller hereby warrants that it has good and marketable title to the described railroad cars and that Seller's title to the described railroad cars is free from all liens and encumbrances (including any leasehold interests therein) other than the Existing Lease described in the attached Exhibit A, the Assignment dated as of March 15, 1987 between Seller and Buyer and the rights of Seller under the Equipment Trust Agreement, and

Seller further agrees to forever warrant and defend the title to the described railroad cars unto Buyer, its successors and assigns, against all lawful claims.
