Whereas, CIS and Ite1 Rail Corporation entered into a Security Agreement dated as of May 11, 1987 (the "Security Agreement");


Whereas, the Security Agreement was filed with the Interstate Commerce Commission on May 14, 1987 (recordation no. 15230); and
