

Memorandum of Lease Agreement for 43 Open Top Hopper cars ("Lease Agreement") made and entered into as of April 8, 1987 by and between CSX Transportation Inc., a Virginia corporation, ("Lessee") and Railmark, Inc., a Florida corporation, ("Lessor").
