
We have filed a lease agreement on July 7, 1982 with the ICC under recordation number 13694.

Dear Jerry:

As per our telephone conversations pertaining to the leasing of one hundred forty (140) covered hopper cars bearing the markings DKS 100-239 inclusive, it is agreed between the parties that Dakota Rail, Inc., has not opted to renew for an additional 66 months as provided in the last paragraph of Schedule I of the Lease Agreement between Rex Railways, Inc., and Dakota Rail, Inc., dated March 29, 1982 and the same paragraph in Schedules II dated June 23, 1982, Schedule III dated September 1, 1982, and Schedule IV dated October 29, 1982, and the Letter Agreement dated August 10, 1983.

It is therefore agreed between the parties that the original Lease Agreements and Subsequent Schedules will be extended for one (1) year with all terms and conditions of the aforesaid Lease Agreement to remain the same with the following exceptions:

1) The last paragraph of Schedule I, II, III and IV will prevail as of October 31, 1985 or at the end of the one (1) year period beginning November 1, 1984 and ending October 31, 1985 as opposed to taking effect November 1, 1983.

2) Rex Railways, Inc. is assigning this Lease Agreement as mentioned above to one of its subsidiaries, Rex Leasing, Inc., who now becomes the Lessor of the cars.

Please sign and notarize four (4) copies of this letter agreement and return three (3) copies for our files.


