

AGREEMENT TO TERMINATE  
INTER CREDITOR SUBORDINATION AGREEMENTS

AGREEMENT, dated January 20 , 1987, by and between the NEW JERSEY ECONOMIC DEVELOPMENT AUTHORITY (the "Authority"), a public body corporate and politic constituting an instrumentality of the State of New Jersey, and HOME & CITY SAVINGS BANK, a banking corporation organized and existing under the laws of the State of New York (the "Bank").

WHEREAS, the Authority and the Bank entered into Inter Creditor Subordination Agreements dated July 12, 1984 and August 22, 1986 ( the "Subordination Agreements") pursuant to which the Authority agreed to subordinate its liens against the assets of The New York, Susquehanna and Western Railway Corporation (hereinafter, the "Borrower") to the liens of the Bank created to secure the repayment by the Borrower of the loans described in the Subordination Agreements; and

WHEREAS, the Borrower has satisfied its obligations to the Bank, and the Authority and the Bank desire, therefore, to cancel and terminate the Subordination Agreements.

NOW, THEREFORE, intending to be legally bound, and in consideration of the foregoing, the parties hereto agree as follows:

1. Effective forthwith, the Subordination Agreements shall be, and hereby are, terminated and canceled and neither party shall hereafter have any further rights, duties or obligations thereunder.


2. This Agreement may be recorded by the Borrower at its expense in each recording office in the State of New Jersey where the Subordination Agreements are recorded.

3. This Agreement shall be binding upon, and inure to the benefit of, the Borrower, the Authority and the Bank and their respective successors and assigns.


4. This Agreement shall be construed according to the laws of the State of New Jersey.






