



AMENDMENT TO  
RAILCAR LEASE AGREEMENT

THIS AMENDMENT is dated as of the 15<sup>th</sup> day of MARCH, 1985 and amends that certain Railcar Lease Agreement dated as of March 31, 1982 (the "Agreement") between Interpool, Limited ("Lessee") and Funding Systems Railcars, Inc. ("Lessor").

WHEREAS the parties hereto are parties to the Railcar Lease Agreement which was filed with the Interstate Commerce Commission at Recordation Number 13627 on April 26, 1982; and

WHEREAS, the parties hereto now desire to amend the Railcar Lease Agreement as hereinafter provided.

NOW THEREFORE, intending to be legally bound hereby, the parties hereto do agree as follows:

1. Effective January 18, 1985 the items of Equipment bearing the identification number DRGW 6022 and DRGW 6048 shall be deleted from Schedule No. 1 and no longer subject to the terms and conditions of the Railcar Lease Agreement.
2. Further modifications. Except as expressly set forth herein, the Agreement shall remain in full force and effect, unamended and unmodified.


