

AMENDMENT TO  
MANAGEMENT CONTRACT

THIS AMENDMENT is dated as of the 16<sup>th</sup> day of FEBRUARY, 1984 and amends that certain Management Contract dated as of November 17, 1983 (the "Agreement") between Barclays American/Business Credit, Inc. (the "Owner") and Funding Systems Railcars, Inc. (the "Manager").

WHEREAS the parties hereto are parties to the Management Contract which was filed with the Interstate Commerce Commission at Recordation number 14242 on December 30, 1983; and

WHEREAS, the parties hereto now desire to amend the Management Contract as hereinafter provided.

NOW THEREFORE, intending to be legally bound hereby, the parties hereto do agree as follows:

1. Equipment The Management Contract covers certain open top hopper railroad cars (the "Equipment") more fully described on Exhibit A to the Agreement. The parties hereto agree that the Manager may change the equipment numbers on certain items of Equipment and that the Agreement and Exhibit A are hereby amended to change the equipment numbers effective as of February 13, 1984 for the following items of Equipment:


