



AMENDMENT TO
MANAGEMENT CONTRACT

THIS AMENDMENT is dated as of the 6th day of NOV., 1984, and amends that certain Management Contract dated as of November 17, 1983 (the "Agreement") between Barclays American/Business Credit, Inc. (the "Owner") and Funding Systems Railcars, Inc. (the "Manager").

WHEREAS the parties hereto are parties to the Management Contract which was filed with the Interstate Commerce Commission at Recordation Number 14242 on December 30, 1983; and

WHEREAS, the parties hereto now desire to amend the Management Contract as hereinafter provided.

NOW, THEREFORE, intending to be legally bound hereby, the parties hereto do agree as follows:

1. Effective May 19, 1984 the item of Equipment bearing the identification number UMP 6336 shall be deleted from Exhibit A and no longer subject to the terms and conditions of the Management Contract.

2. Further Modifications. Except as expressly set forth herein, the Agreement shall remain in full force and effect, unamended and unmodified.
