RELEASE OF PART OF MORTGAGED PROPERTY  
INTERSTATE COMMERCE COMMISSION

AGREEMENT to Release Part of Mortgaged Property made this 31<sup>st</sup> day of December, 1982 between Marine Midland Bank, N.A. (the "Mortgagee"), a national banking association, with offices at One Marine Midland Plaza, Rochester, New York 14639 and GWI Leasing Corporation (the "Mortgagor"), a Delaware Corporation with offices at 71 Lewis Street, Greenwich, Connecticut 06830.
