WHEREAS, TEXAS COMMERCE BANK NATIONAL ASSOCIATION ("Texas Commerce"), a national banking association, and John T. Files ("Debtor") entered into that certain Security Agreement dated May 15, 1984, pursuant to which John T. Files granted to Texas Commerce a security interest in five (5) 23,500 gallon nominal capacity tank cars, DOT111A100, coiled and insulated; 100-ton roller bearing trucks, Registration Numbers GLNX 83010, 83011, 83012, 83013 and 83014, and all additions and accessions thereto, rentals and profits therefrom, all accounts, chattel paper and general intangibles with respect thereto and proceeds thereof and all right, title and interest of Debtor in that certain Management Agreement by and between GLNX Corporation, a Texas corporation, and Debtor dated as of May 23, 1983 (the "Tank Cars");

WHEREAS, Texas Commerce and Debtor have entered into a new Security Agreement whereby Debtor has granted Texas Commerce a security interest in and pledged to Texas Commerce ~~all of the 5,000 outstanding shares of~~ Flying F Company (the "Shares"); and PB

WHEREAS, in exchange for such new Security Agreement, Texas Commerce has agreed to release its security interest in the Tank Cars.

NOW, THEREFORE, in consideration of the substitution of the Shares as collateral for the Tank Cars, Texas Commerce does hereby RELEASE its security interest in the Five (5) 23,500 gallon nominal capacity tank cars, DOT111A100, coiled and insulated; 100-ton roller bearing trucks, Registration Numbers GLNX 83010, 83011, 83012, 83013 and 83014, and all additions and accessions thereto, rentals and profits therefrom, all accounts, chattel paper and general intangibles with respect thereto and proceeds thereof and all right, title and interest of Debtor in that certain Management Agreement by and between GLNX Corporation, a Texas corporation, and Debtor dated as of May 23, 1983.
