



AMENDMENT TO RAILROAD EQUIPMENT LEASE

INTERSTATE COMMERCE COMMISSION

THIS AMENDMENT to Railroad Equipment Lease as of December 1, 1984 by and between State Street Bank and Trust Company, a Massachusetts corporation ("SSBT") and Greenbrier Leasing Corporation, a Delaware corporation ("Greenbrier").

W I T N E S S E T H:

WHEREAS, SSBT and Greenbrier have entered into a Railroad Equipment Lease dated as of June 1, 1984, which was filed with the Interstate Commerce Commission on June 28, 1984, and assigned recordation number 14356; and


