BACKGROUND

A. On August 2, 1984 Girard Leasing Corporation filed with the Commission the aforementioned documents, which relate to thirty-eight (38) 50'6" 70-ton XM rated boxcars bearing Road Numbers in non-inclusive series SFLC 900000 to 900050.

B. At the time of the aforementioned filing on August 2, 1984 a typographical error in listing the Road Numbers of six (6) of the thirty-eight boxcars was made on Exhibit "A" to the Partial Termination, Schedule "A" to the Unconditional Release and Schedule "A" to the Bill of Sale, in that a digit was inadvertently omitted from the correct number for each boxcar.

C. The correct Road Numbers for the six aforementioned boxcars is as shown in the Statement of New Numbers, filed with the Commission on August 6, 1981 and assigned recordation number 9605-N.
