



NOTICE IS HEREBY GIVEN; that,

INTERSTATE COMMERCE COMMISSION

GREYHOUND LEASING & FINANCIAL CORPORATION (Greyhound), a Delaware corporation having its principal place of business at Greyhound Tower, Phoenix, Arizona 85077 and RAILTEX, INC. ("Railtex"), a Texas corporation having its principal place of business at 4901 Broadway, Suite 231, San Antonio, Texas 78209 did on May 29, 1984 terminate and rescind the following:

- (i) a certain Equipment Lease dated as of July 10, 1978 ("Lease Agreement") between Greyhound, as lessor therein, and Railtex, as lessee therein, and filed with the Interstate Commerce Commission on December 20, 1978 as Recordation No. 9926;
- (ii) a certain Conditional Sale and Security Agreement dated as of January 9, 1979 ("Sale Agreement") between Greyhound, as seller therein, and Railtex, as purchaser therein, and filed with the Interstate Commerce Commission on May 1, 1979 as Recordation No. 10328; and,
- (iii) a certain Chattel Mortgage and Security Agreement dated as of January 9, 1979 ("Security Agreement" and together with the Lease Agreement and Sale Agreement hereinafter referred to collectively as the "Agreements") between Greyhound, as mortgagee therein, and Railtex, as mortgagor therein, and filed with the Interstate Commerce Commission on May 1, 1979 as Recordation No. 10328A.

BE IT KNOWN, the Agreements and all documents and instruments thereunto appertaining having been terminated and rescinded as of May 29, 1984 the parties hereunto desire to confirm and record the same.

BE IT FURTHER KNOWN, the parties hereunto do hereby acknowledge, ratify and confirm the termination and rescission of the Agreements and all documents and instruments thereunto appertaining and that the personalty mentioned in the Agreements is no longer subject to the terms and provisions thereof. Notwithstanding anything contained to the contrary in this Notice of Termination, Sections 26, 29 and 21 of the Lease Agreement, Sale Agreement and Security Agreement, respectively, did survive the aforementioned termination and rescission and remain in full force and effect in accordance with the terms and conditions contained in each therein, only as to: (i) Sections 8, 9(a)(c)(e) and 12(c) of the Lease Agreement; (ii) Sections 7(a), 11, 12(c) and 15(c) of the Sale Agreement; and, (iii) Sections 7(b) and 10(c) of the Security Agreement.

NOW, THEREFORE, the parties hereunto have made and delivered this Notice of Termination the day and year below written.


