

SUPPLEMENTAL AGREEMENT DATED AS OF August 1, 1980  
TO EQUIPMENT TRUST AGREEMENT DATED AS OF August 15, 1973

BY AND BETWEEN

CONTINENTAL ILLINOIS NATIONAL BANK AND TRUST COMPANY OF CHICAGO, TRUSTEE

AND

GATX CORPORATION  
(Formerly known as General American Transportation Corporation)

Supplemental Agreement dated as of August 1, 1980,  
by and between CONTINENTAL ILLINOIS NATIONAL BANK AND TRUST COMPANY (CHICAGO, a national banking association, as Trustee, and GATX Corporation a New York corporation formerly known as General American Transportation Corporation.

WHEREAS, the parties hereto entered into an Equipment Trust Agreement dated as of August 15, 1973 (the "Agreement creating General American Transportation Corporation Equipment Trust, Series 70", which Agreement was filed and recorded with the Interstate Commerce Commission pursuant to Section 20c of the Interstate Commerce Act on August 31, 1973, Recordation No. 7145; and

WHEREAS, the parties hereto wish to amend Schedule I to the Agreement;

NOW, THEREFORE, the parties hereto agree that Schedule I to the Agreement is hereby amended by:

(a) deleting therefrom the units of Trust Equipment described in Schedule I attached hereto, and

(b) substituting therefor the units of Equipment described in Schedule II attached hereto.
