

NOTICE OF RENUMBERING

RECITALS:

1. October Equipment Leasing Company, as Lessor, and the Detroit, Toledo and Ironton Railroad Company, as Lessee, entered into a railroad equipment lease ("Lease"), dated as of October 1, 1973, covering eight diesel electric locomotives, which Lease was recorded with the Interstate Commerce Commission on October 9, 1973 and assigned recordation No. 7175. The Lease has been assigned to Northwestern National Life Insurance Company.

2. Said locomotives are GP 40-2 diesel electric locomotives, numbered 414 through 421, both inclusive.


