SUPPLEMENT, dated as of October 19, 1982, to the BAILMENT AGREEMENT AND ASSIGNMENT OF LEASES, dated as of November 2, 1979 (the "Assignment"), between General Electric Credit And Leasing Corporation, a Delaware corporation ("GECC"), and NORTH AMERICAN CAR CORPORATION, a Delaware corporation ("NACC"):

2.01. The Assignment is hereby supplemented to add the Leases thereto.

Article III. Representation and Warranties

3.01. The representations, warranties and covenants of NACC in the Assignment are true and correct on and as of the date hereof as though made on and as of this date.




