

INTERSTATE COMMERCE COMMISSION

Amendment to Lease dated January 1, 1982 by and between Evans Railcar Leasing Company (formerly United States Railway Leasing Company) (the "Lessor") and Columbus and Greenville Railway Company (the "Lessee");

W I T N E S S E T H :

WHEREAS, Lessor and Lessee have previously entered into that certain Lease dated May 15, 1980 (the "Lease") which covered twenty-three (23) used 100-ton 4790 cubic foot covered hopper cars with trough hatches and gravity discharge gates (Former NRUC Lot 1722-00) bearing reporting mark and numbers CAGY 300-322, both inclusive; and

WHEREAS, the Lease was recorded with the Interstate Commerce Commission (the "ICC") on July 24, 1980 at 11:20 a.m. as Recordation No. 12036; and

WHEREAS, the reporting numbers noted above have been changed; and

WHEREAS, the parties hereto agree to amend the Lease to reflect the change as provided herein;

NOW THEREFORE, for and in consideration of the premises and the payment of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

1. The Lease as recorded with the ICC is hereby amended by deleting therefrom reference to reporting mark and numbers "CAGY 300-322, both inclusive" and substituting therefor "CAGY 208135-208159, both inclusive, excluding 208136 and 208137".

2. Except as hereby amended, all of the terms and provisions of the Lease remain in full force and effect and the Lease as amended is hereby ratified, confirmed and approved.
