



AMENDMENT
TO
AGREEMENT OF LEASE

THIS AMENDMENT is dated as of the 22nd day of January, 1982 and amends that certain Agreement of Lease dated as of the 31st day of July, 1980 (the "Lease") between Film Properties, Inc. (the "Lessor") and Funding Systems Railcars, Inc. (the "Lessee").

WHEREAS the parties hereto are parties to the Lease Agreement which was filed with the Interstate Commerce Commission at Recordation Number 12053 on July 30, 1980; and

WHEREAS, the parties hereto now desire to amend the Lease Agreement as hereinafter provided.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto do hereby agree as follows:

1. Equipment The Lease Agreement covers certain gondola railroad cars (the "Equipment") more fully described on a Schedule to the Lease Agreement. The parties hereto agree that the Lessee may change the equipment numbers on certain items of the Equipment and that the Lease Agreement and Schedule thereto are hereby amended to change the equipment numbers of the following items of Equipment:
