EQUIPMENT TRUST AGREEMENT SUPPLEMENT NO. 1 dated as of August 1, 1981, by and between CONTINENTAL ILLINOIS NATIONAL BANK AND TRUST COMPANY OF CHICAGO, a national banking association organized and existing under the laws of the United States of America, as Trustee (hereinafter called the Trustee) and TRAILER TRAIN COMPANY, a Delaware corporation (hereinafter called the Company).

WHEREAS, the parties hereto have entered into an Equipment Trust Agreement dated as of October 22, 1980 (hereinafter called the Trust Agreement) providing for the sale, transfer and delivery to the Trustee of certain railroad equipment described in Schedule A thereto;

WHEREAS, the Trust Agreement has been filed and recorded with the Interstate Commerce Commission pursuant to the requirements of 49 U.S.C. § 11303 (a) on October 27, 1980, at 10:55 a.m. and assigned recordation number 12345; and

WHEREAS the parties hereto desire to supplement Schedule A of the Trust Agreement to add 101 ACF Industries, Inc. intermodal cars (as more fully described in Schedule A) car numbers 60000 thru 60100; and

WHEREAS this inclusion of equipment is authorized by the second paragraph of Section 4.01 of the Trust Agreement and the entering into of this Supplement No. 1 by the Trustee and the Company without the consent of the holder of the Trust Certificates issued pursuant to the Trust Agreement is authorized by Section 12.01 of the Trust Agreement;

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the parties hereto hereby agree as follows:


- (1) Schedule A is hereby supplemented and restated in its entirety as set forth in Exhibit 1 hereto, and
- (2) The Company will promptly cause this Supplement No. 1 to be filed and recorded with the Interstate Commerce Commission pursuant to the requirements of 49 U.S.C. § 11303 (a) and in accordance with the terms of Section 5.03 of the Trust Agreement.

Except as supplemented hereby, the Trust Agreement shall remain unaltered and in full force and effect.

Any and all notices, requests, certificates and other instruments executed and delivered after the execution and delivery of this Supplement No. 1 may refer to the "Equipment Trust Agreement dated as of October 22, 1980" without making specific reference to this Supplement No. 1, but nevertheless all such references shall be deemed to include this Supplement No. 1 unless the context shall otherwise require.


