REX for itself in its name, warrants and represents to Owner that it has full power and authority to execute and perform this Agreement; that it owns the Equipment free and clear of all liens, damage claims, charges and encumbrances of any kind whatsoever; that it has not collaterally assigned or otherwise assigned or granted any third party any rights in the Equipment; and that the title conveyed is good, its transfer is rightful, and the Equipment is, has been or shall be delivered free and clear of any security interest or other lien or encumbrance and hereby indemnifies Owner accordingly against any attack on title relative to the Equipment.
