

This Assignment of Leases made this 1st day of April, 1989 between Citicorp Leasing, Inc. ("CLI") and Citicorp Railmark, Inc. ("CRI").

WHEREAS, by Bill of Sale dated the date hereof, CLI has sold to CRI the railroad freight cars described on Schedule A hereto (the "Equipment"), which cars are subject to various leasing agreements (the "Leases") with various lessees as described on Schedule A hereto; and

WHEREAS, CLI desires to assign the Leases to CRI and CRI desires to obtain all of the rights and benefits of CLI under the Leases and is willing to assume, from and after the date hereof, the obligations and liabilities of CLI under the Leases.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignment of Leases. Effective the date hereof, CLI hereby transfers, sells and assigns to CRI all of CLI's right, title and interest, powers, privileges and other benefits in and to the Leases, including, without limitation, the right to receive all rentals and other amounts payable by any Lessee under any Lease.

2. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York.
