SUBORDINATION AGREEMENT INTERSTATE COMMERCE COMMISSION

WHEREAS, Gibbs-Cook Equipment Co. ("Gibbs-Cook") and PappaJohn, Shriver, Eide & Nicholas, 800 Brick and Tile Building, Mason City, Iowa ("Creditor") have filed or intend to file recordation of a Primary Document with the Interstate Commerce Commission providing notification of a possible security interest in certain equipment of Vining Enterprises Inc. ("Debtor") and the proceeds thereof; and

WHEREAS, it is the intention of Gibbs-Cook and Creditor to avoid possible conflicting security interests arising from the filing of said financing statements.

NOW, THEREFORE, the parties hereto agree as follows:

1. Creditor hereby agrees to subordinate its security interest in the equipment of Debtor to Gibbs-Cook with respect to equipment described

- One Railroad Locomotive No. 102, Serial # F7A6098B EMO 17852,
- One Railroad Locomotive No. 103, Serial # F7AF2C98 EMO 11073

or in proceeds resulting from the sale or disposition of such equipment.

2. Gibbs-Cook hereby agrees to subordinate its security interest to the interest of Creditor with respect to any and all other equipment of Debtor, except the equipment noted above and any equipment of Debtor as to which Gibbs-Cook holds a purchase money security interest.

3. Except as herein otherwise provided, priority as between the security interests of Gibbs-Cook and Creditor shall be determined in accordance with the Uniform Commercial Code as now or hereafter in effect in the state of Iowa.

4. This agreement shall be binding upon the successors and assigns of Creditor and inure to the benefit of the successors and assigns of Gibbs-Cook and Creditor.

IN WITNESS WHEREOF, the authorized representatives of the parties hereto have duly executed this agreement to be effective as of this 5th day of August, 19 88.
