INTERSTATE COMMERCE COMMISSION

WHEREAS, pursuant to a Lease dated May 1, 1977, (the "Lease") by and between Union-Tidewater Financial Company, Inc., whose address is P.O. Box 2373, Baltimore, Maryland 21203 (the "Lessor") and the Maryland and Pennsylvania Railroad Company, whose address is 490 East Market Street, York, Pennsylvania ("M & P"), which Lease was filed with the Interstate Commerce Commission on May 10, 1977, under Recordation Number 8816, Lessor leased certain boxcars to the M & P, including the 21 boxcars bearing the serial numbers set forth on Schedule A annexed hereto; and

WHEREAS, the serial numbers of such 21 boxcars leased under the Lease have been changed and the parties wish to amend the Lease and/or the schedules and exhibits annexed thereto to reflect such change in serial numbers.
