

**FIRST AMENDMENT  
TO NEW COVENANT AGREEMENT**

INTERSTATE COMMERCE COMMISSION

This First Amendment is dated as of September 18, 1986, to the New Covenant Agreement ("New Covenant Agreement") dated as of September 19, 1983, by and between ITEL Rail Corporation ("Rail") and First Security Bank of Utah, N.A. (the "Trustee") not in its individual capacity but solely as Trustee under Equipment Trust Agreements dated as of May 15, 1977, June 15, 1977, July 15, 1977, August 1, 1977 and August 15, 1977, for the parties identified on Exhibit A to the New Covenant Agreement or the successors or transferees of such parties (the "Holders").


WHEREAS, the Trustee has received from the Holders of greater than two-thirds of aggregate unpaid principal amount of 1977 Series 3 ETC's (as defined in the New Covenant Agreement) consents to the elimination of Article Two of the New Covenant Agreement.

NOW, THEREFORE, in consideration of the premises, the parties agree to amend the New Covenant Agreement as follows:

1. Article Two of the New Covenant Agreement is hereby deleted in its entirety, effective as of September 18, 1986.




