THIS GENERAL AMENDMENT, dated as of October 1, 1987 (the "General Amendment"), is by and among FIRSTIER BANK, N.A., as Agent (the "Agent"), INSPIRATION LEASING INC. (the "Lessor"), USI CHEMICALS CO. DIVISION OF NATIONAL DISTILLERS & CHEMICAL CORPORATION (the "Lessee"), ENRON CORP. (the "Guarantor"), UNITED OF OMAHA LIFE INSURANCE COMPANY (an "Investor"), and WOODMEN OF THE WORLD LIFE INSURANCE SOCIETY (an "Investor"), and amends each of the following agreements (the agreements and instruments identified below are hereinafter referred to, collectively, as the "Original Agreements" and, as amended by this General Amendment, the Original Agreements are hereinafter referred to, collectively, as the "Amended Agreements"):

Participation Agreement, dated as of November 1, 1981, among The Omaha National Bank, as Agent, Merrill Lynch Leasing Inc., as Lessor, Northern Petrochemical Company, as Lessee, Internorth Inc., as Guarantor and United Benefit Life Insurance Company and Woodmen of the World Life Insurance Society as Investors;

Agency Agreement, dated as of November 1, 1981, among The Omaha National Bank, United Benefit Life Insurance Company and Woodmen of the World Life Insurance Society;

Assignment of Purchase Agreements, dated as of November 1, 1981, between Northern Petrochemical Company and Merrill Lynch Leasing Inc.;

Lease of Railroad Equipment, dated as of November 1, 1981, between Merrill Lynch Leasing Inc. and Northern Petrochemical Company, as supplemented by Supplement I to the Lease, dated as of December 3, 1981, and Supplement II to the Lease, dated as of December 21, 1981;

Guaranty Agreement, dated as of November 1, 1981, between Internorth Inc. and Merrill Lynch Leasing Inc.;

Security Agreement, dated as of November 1, 1981, between The Omaha National Bank, as agent and Merrill Lynch Leasing Company Inc., as supplemented by Supplement I to the Security Agreement, dated as of December 3, 1981, and Supplement II to the Security Agreement, dated as of December 21, 1981;

Promissory Notes, dated November 10, 1981, December 3, 1981 and December 21, 1981, from Merrill Lynch Leasing Inc. to The Omaha National Bank, as agent;

Certificates of Interest, dated November 10, 1981, December 3, 1981 and December 21, 1981, from The Omaha National Bank, as agent, to United Benefit Life Insurance Company;

Certificates of Interest, dated November 10, 1981, December 3, 1981 and December 21, 1981, from The Omaha National Bank, as agent, to Woodmen of the World Life Insurance Society.

RECITALS

WHEREAS, certain of the parties to the Original Documents have been the subject of mergers, changes in ownership or changes in corporate names;

WHEREAS, for administrative convenience and to affirm the obligations and rights of the parties hereto with respect to the Original Documents, the parties hereto desire to amend the Original Documents to reflect such mergers and changes;

WHEREAS, all of the parties to the Original Documents are parties hereto;

NOW, THEREFORE, in consideration of the mutual agreements set forth herein and for other good and valuable consideration, receipt of which is hereby acknowledged, the parties hereto agree as follows:

Section 1.1. Amendment of Names and Notice of Address.

Wherever in the Original Agreements the former name of any of the parties listed below appears, such former name is amended to read as indicated below under the heading "Current Name." The current address and telephone number of each of the parties is also indicated below, and this General Amendment shall constitute written notice of any change in address for the purposes of any notice provision in the Amended Agreements.

Section 1.2. Original Agreements in Full Force and Effect as Amended. This General Amendment shall constitute an amendment to each of the Original Agreements and, as so amended, each of the Original Agreements shall remain in full force and effect. All references in any Original Agreement to such Original Agreement or any other Original Agreement shall mean such Original Agreement or other Original Agreement, as the case may be, as amended by this General Amendment.

Section 1.3. Representations and Warranties. Each of the parties hereto represents and warrants to the other parties that:

(a) it has the power to enter into this General Amendment and to consummate the transactions contemplated hereby; and

(b) this General Amendment has been duly authorized, executed and delivered by it and, assuming the due authorization, execution and delivery hereof by the other parties hereto, constitutes a legal, valid and binding obligation of it enforceable against it in accordance with the terms hereof, subject to applicable

bankruptcy, insolvency and similar laws affecting creditors' rights generally, and subject, as to enforceability, to general principles of equity (regardless of whether enforcement is sought in a proceeding in equity or at law).


Section 1.4. Recordation. Promptly after this General Amendment shall have become effective in accordance with Section 1.6 hereof, this General Amendment shall be duly filed with the Interstate Commerce Commission in accordance with 49 U.S.C. §11303.

Section 1.5. Expenses. As contemplated in Section 12(i) of the Participation Agreement, the Lessee agrees to pay all of the costs and expenses incurred by the Agent and the Investors in connection with the preparation, execution and delivery of this General Amendment, including the reasonable fees and disbursements of Kutak Rock & Campbell as special counsel to the Agent. As contemplated in Section 15 of the Lease, the Lessee agrees to pay the reasonable fees and expenses in connection with the recording of this General Amendment with the Interstate Commerce Commission pursuant to 49 U.S.C. §11303.

Section 1.6. Counterparts and Effective Date. This General Amendment may be executed in any number of counterparts, but the counterparts delivered and retained by the Agent shall be deemed to constitute the sole original. Upon receipt by the Agent of counterparts of this General Amendment executed by each party hereto, this General Amendment




