TERMINATION OF RAILCAR SECURITY AGREEMENT

THIS TERMINATION OF SECURITY AGREEMENT is made this 25th day of June, 1999, by and between Johnstown America Corporation ("JAC"), and The Detroit Edison Company ("Lessee")

WHEREAS, JAC and Lessee are parties to a Memorandum of Railcar Security Agreement, dated as of June 17, 1999 (the "Security Agreement"); and

WHEREAS, the Security Agreement created a lien and security interest in favor of JAC in and to the railcars described on Schedule 1 attached hereto (the "Equipment"); and

WHEREAS, the Security Agreement was duly filed for recordation with the Surface Transportation Board (the "STB") pursuant to 49 U.S.C. Section 11301, on June 21, 1999, and assigned recordation number 22204; and

WHEREAS, JAC and Lessee desire to terminate and cancel the Security Agreement and to record such termination and cancellation with the STB;

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, JAC and Lessee, intending to be legally bound, agree as follows:

1. JAC and Lessee hereby terminate and cancel the Security Agreement, effective as of the date this Termination of Security Agreement is filed with the STB, and JAC and Lessee hereby agree that no rights, duties or liabilities under the Security Agreement shall survive such termination and cancellation of the Security Agreement.
2. The parties agree to record this Termination of Security Agreement with the STB so as to release any lien against the Equipment created by or arising out of the Security Agreement.
3. This Termination of Security Agreement may be executed in any number of counterparts, each executed counterpart constituting an original but all together constituting only one and the same agreement.

IN WITNESS WHEREOF, JAC and Lessee have caused this Termination of Security Agreement to be executed as of the day and year first above written.


