MEMORANDUM OF LEASE AGREEMENT

This MEMORANDUM OF LEASE, dated as of July 27, 1999, is between Newcourt Capital USA, Inc., a Delaware corporation ("Lessor"), and Commonwealth Edison Company, an Illinois corporation ("Lessee").

1. Lessor hereby leases to Lessee one hundred twenty-two (122) aluminum rapid discharge AutoFlood II hopper railcars, manufactured by Johnstown America Corporation, and more fully described in Schedule I hereto (the "Units"). The Commencement Date as to a Unit begins on the date set forth in Rider #3, executed with respect to such Unit by Lessor and Lessee pursuant to the Lease Agreement dated as of July 27, 1999, between Lessor and Lessee (the "Lease"), and terminates on September 30, 2017, unless extended or earlier terminated pursuant to the provisions of the Lease.

2. Lessee shall pay Rent for the Units as set forth in the Lease.

3. This Memorandum of Lease is a summary of, and in all respects is subject to, the terms of the Lease.

4. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed to such terms in the Lease.


