WHEREAS, under a Lease of Railroad Equipment dated as of July 15, 1971 among D. E. Mundell and Ben Maushardt as Trustees, Lessor, (the "Trustees") and United States Leasing International, Inc., as Agent for the Trustees and Union Carbide Corporation (the "Lessee"), Lessee acquired the possession and use of the railroad equipment (the "Equipment") with the Road Numbers as shown above; and

WHEREAS, under the Security Agreement dated as of December 27, 1971 from the Trustees (the "Debtor") to Indianapolis Life Insurance Company (the "Secured Party"), the Debtor conveyed, mortgaged, assigned, pledged and granted to the Secured Party a security interest in and to its rights, title and interest to the Equipment subject to the Lease to secure payment of a certain 8 1/2% Secured Note (the "Note") dated as of January 4, 1972; and

WHEREAS, the Security Agreement was filed with the Interstate Commerce Commission and assigned ICC Recordation Number 6448; and

WHEREAS, on or about October 15, 1991 all principal of and interest on the Note has been paid to the Secured Party; and

WHEREAS, the Debtor wishes to sell the Equipment and desires that the Secured Party release its security interest in the Equipment.

NOW THEREFORE, for good and valuable consideration, the Secured Party acknowledges payment in full of all sums due under the Note, confirms the cancellation of the Note, and relinquishes its security interest and all of its right, title and interest in and to the Equipment.
