

THIS BILL OF SALE ("Bill of Sale") is made this 25th day of September, 1990 by United States Trust Company of New York as owner trustee ("Seller") in favor of GATX Capital Corporation ("Buyer").

R E C I T A L S

A. Seller and Buyer entered into an Agreement of Purchase and Sale of Locomotives dated as of August 14, 1990 (the "Agreement") for the sale of thirty (30) SD 40-2 locomotives.

B. Seller desires to give this Bill of Sale for the purpose of effecting the purchase and sale of nineteen (19) of the Locomotives as more fully described in Exhibit A attached hereto (the "Locomotives") pursuant to the provisions of the Agreement.

For the sum of \$1.00 and other good and valuable consideration, the adequacy and receipt of which is acknowledged by Seller, **SELLER AGREES AS FOLLOWS:**

1. Sale of Equipment. Seller does hereby sell, convey, assign and transfer to Buyer the Locomotives. The Locomotives are sold "as is," "where is, and "with all faults." Seller hereby sells, assigns and transfers to Buyer any and all such rights and benefits as Seller may now or hereafter have under any warranty, guarantee or indemnity with respect to the Locomotives against any manufacturer or supplier thereof or any part thereof, on any contractor or subcontractor or any such manufacturer or supplier.

2. Warranty of Ownership. Seller does hereby covenant and warrant that it is the lawful owner of the Locomotives and has good, indefeasible, valid and marketable title in and to the Locomotives free and clear of all claims, liens, encumbrances, security interests and rights of third parties of any nature whatsoever arising by or through Seller and Seller has the right to sell the same.

Seller represents and warrants that it is not required to comply with any bulk sales or similar laws with respect to the sale of the Locomotives.

3. Indemnity. Seller will warrant and defend title to the Locomotives against all and every person and persons whomsoever claiming or laying claim to the same by or through Seller.

Seller hereby agrees to indemnify Buyer and hold it harmless from and against any and all loss, cost, damage or expense (including reasonable attorneys fees) it may suffer as a result of any claims, demands, suits, actions, causes of action, recoveries or judgments arising out of any claim of title to the Locomotives or any lien thereon and arising on or prior to the date hereof, by any person described in the first paragraph of this Section.

4. No Rights in Third Party. Nothing expressed or implied in this Bill of Sale is intended to confer upon any person other than parties hereto and their respective successors and assigns, any rights, remedies, obligations or liabilities under or by reason of this Bill of Sale.

5. Successors and Assigns. This Bill of Sale shall be binding upon and inure to the benefit of Seller and Buyer and their respective successors and assigns.

6. Governing Law. This Bill of Sale shall be construed in accordance with, and governed by, the laws of the state of New York.


