BILL OF SALE

INTERSTATE COMMERCE COMMISSION

KNOW ALL MEN BY THESE PRESENTS, that Electro-Motive Division, General Motors Corporation, a Delaware corporation with an office and principal place of business at 9301 W. 55th Street, La Grange, Illinois 60525 ("Seller"), for and in consideration of the sum of Ten (\$10.00) Dollars and other good and valuable consideration received from ATEL Cash Distribution Fund IV, a California limited partnership with an office and principal place of business at 235 Pine Street, 6th Floor, San Francisco, California 94104 ("Buyer"), the receipt and sufficiency of which is hereby acknowledged by Seller, has bargained, sold, transferred, assigned, set over and conveyed, and by these presents does hereby bargain, sell, transfer, assign, set over and convey unto Buyer, its successors and assigns forever the equipment described in the Schedule A annexed hereto (the "Equipment").

Seller represents and warrants to Buyer that Seller has and hereby conveys to Buyer good and marketable title to the Equipment, free and clear of all liens, claims, charges and encumbrances, direct or indirect, except for the lien in favor of Seller pursuant to the Remarketing Agreement between Buyer and Seller dated as of December 30, 1992 and as specified in the following paragraph, that Seller is the lawful owner of the Equipment and that Seller has a good and lawful right to sell the same and will defend said title.

By acceptance of this Bill of Sale, Buyer agrees and acknowledges that its interest in the Equipment conveyed to it by this Bill of Sale is subject and subordinate to the rights of Burlington Northern under the Burlington Lease, as those terms are defined in a certain purchase agreement between Seller and Buyer dated as of December 30, 1992 (the "Purchase Agreement").

IN WITNESS WHEREOF, Seller has caused this Bill of Sale to be executed as of this 13th day of January, 1993.


