Re: Notice of Name Change

Ladies and Gentlemen:

Notice is hereby given that on December 1, 1995, Shawmut Bank Connecticut, National Association ("SBC") changed its name to Fleet National Bank of Connecticut ("FNBC"). This change of name resulted from the merger of Shawmut National Corporation, the parent company of SBC, with and into Fleet Financial Group, Inc. FNBC will be operated as a wholly owned bank subsidiary under SBC's existing charter with the Comptroller of the Currency. Enclosed with this letter is a Certificate issued by the Comptroller of the Currency evidencing the name change.

FNBC acts as owner trustee in several rolling stock lease transactions where certain of the financing instruments are filed with the Interstate Commerce Commission. Please amend your records with respect to the following filings to reflect the name change to FNBC:




