Ladies and Gentlemen:

Notice is hereby given that on April 1, 1996, Fleet National Bank of Connecticut changed its name to Fleet National Bank. This change of name resulted from the consolidation by Fleet Financial Group, Inc., the parent company of Fleet National Bank of Connecticut, of several of its national bank subsidiaries into the charter of Fleet National Bank of Connecticut. The consolidated bank is named "Fleet National Bank." Enclosed with this letter is a Certificate issued by the Comptroller of the Currency evidencing the name change.

Fleet National Bank acts as owner trustee in several rolling stock lease transactions where certain of the financing instruments are filed with the Surface Transportation Board. Please amend your records with respect to the following filings to reflect the name change to Fleet National Bank:


