

SEABOARD COAST LINE RAILROAD EQUIPMENT TRUST NO. 13 OF 1980

DATED AS OF JANUARY 15, 1980

KNOW ALL MEN BY THESE PRESENTS that Mercantile-Safe Deposit and Trust Company, Trustee under a certain Equipment Trust Agreement dated as of January 15, 1980, between the Trustee and Seaboard Coast Line Railroad Company, said Agreement establishing Seaboard Coast Line Railroad Equipment Trust of 1980, hereby certifies that it has been informed by CSX Transportation, Inc. (successor by merger to Seaboard Coast Line Railroad Company) that 13 Model GP-16 1600 H. P. diesel-electric locomotives (the "Equipment") subject to said Equipment Trust Agreement have been reported destroyed, worn out or found unsuitable for use, and CSX Transportation, Inc. has deposited with it the fair value of the Equipment.

Mercantile-Safe Deposit and Trust Company does hereby sell, assign, convey, transfer, set over, release and quitclaim without warranty or guaranty of any kind, express or implied, unto CSX Transportation, Inc. all of its right, title and interest in and to all of the Equipment listed in Schedule A hereto, and affirms that the Equipment is free from any lien or claim by Mercantile-Safe Deposit and Trust Company under said Equipment Trust Agreement or otherwise.


