LEASE AMENDMENT

INTERSTATE COMMERCE COMMISSION

This Amendment to that certain Lease of Railroad Equipment made and entered into as of the 30th of June, 1988 (hereinafter the "Effective Date") by and between Helm Financial Corporation, a California corporation, and Indiana Hi-Rail Corporation, an Indiana corporation.

This Amendment shall modify the above referenced Lease as follows:
