





This Release (this "Release"), dated as of September 29, 1995, is made and granted by CIBC Leasing Inc., a Delaware corporation ("CIBC").

W I T N E S S E T H

WHEREAS, pursuant to the Purchase Agreement, dated as of October 31, 1988, between CIBC and Louis Dreyfus Corporation, a New York corporation (the "Company") (TBT Covered Hopper Cars) (as amended, supplemented or otherwise modified from time to time, the "Purchase Agreement"), CIBC purchased the Equipment (as defined in the Purchase Agreement and as set forth on Schedule A hereto) from the Company;

WHEREAS, pursuant to the Equipment Lease, dated as of October 31, 1988, between CIBC, as Lessor, and the Company, as Lessee, (as amended, supplemented or otherwise modified from time to time, the "Equipment Lease"), the Company leased the Equipment from CIBC;

WHEREAS, the Equipment Lease, naming the Company as Lessee and CIBC as Lessor, was filed with the Interstate Commerce Commission on November 1, 1988, File No. 16001, recording CIBC's security interest in the Equipment pursuant to 49 U.S.C. §11303.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt of which is hereby acknowledged, CIBC agrees as follows:

1. CIBC declares to be satisfied in full and forever waives and releases in favor of the Company its liens, charges, encumbrances and security interests in and to the Equipment under the Equipment Lease and the receivables, proceeds and revenues arising from the Equipment under the Equipment Lease and agrees to take all further action and to execute all such further documents as it deems necessary or advisable to accomplish the purposes of this Release.

2. This Release shall not be amended, modified or supplemented except by a writing signed by CIBC. **THIS RELEASE SHALL BE INTERPRETED, GOVERNED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO THE CONFLICT OF LAW PRINCIPLES THEREOF.**
