MEMORANDUM OF ASSIGNMENT OF EQUIPMENT LEASE SCHEDULE

THIS MEMORANDUM OF ASSIGNMENT OF EQUIPMENT LEASE SCHEDULE (this "Assignment") is made and entered into as of December 8, 1999, by and between GENERAL ELECTRIC BUSINESS ASSET FUNDING CORPORATION ("Assignor") and ICX CORPORATION ("Assignee").

Assignor, successor to MetLife Capital, Limited Partnership, the assignee of NationsBanc Leasing Corporation, as lessor, and Dakota, Minnesota & Eastern Railroad Corporation, as lessee ("Lessee"), have heretofore entered into that certain Equipment Lease Schedule Number 3 dated as of July 31, 1996 ("Lease Schedule"), pursuant to, and incorporating the terms and provisions of, that certain Master Equipment Lease Agreement dated as of April 9, 1996 between Assignor and Lessee (the "Master Lease") (the Lease Schedule and the Master Lease, to the extent incorporated in the Lease Schedule, hereinafter referred to as the "Lease") pertaining to the railcars described in the Lease (the "Railcars"). The Master Lease was filed on June 19, 1996 under Recordation Number 20144 with the Surface Transportation Board (formerly known as the Interstate Commerce Commission) ("STB") pursuant to 49 U.S.C. § 11301. The Lease Schedule was filed on August 12, 1996 under Recordation Number 20144-B with the STB pursuant to 49 U.S.C. § 11301.

Concurrently herewith, Assignor has assigned to Assignee all right, title and interest of Assignor in and to the Railcars and the Lease; and the parties desire to effect the assignment of the rights of Assignor under the Lease.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) in hand paid, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest of Assignor in, to and under the Lease; and Assignee accepts such assignment.

This Assignment may be executed in any number of counterparts, each executed counterpart constituting an original but altogether only one and the same assignment.
