


MEMORANDUM OF SECURITY AGREEMENT

This Memorandum of Security Agreement, dated as of November 10, 1997, by and between MARVIN H. WEINER (the "Borrower"), and CRESTAR LEASING CORPORATION (the "Lender").

1. The Lender has made a loan to the Borrower pursuant to a Loan and Security Agreement, dated as of November 10, 1997 (the "Security Agreement").

2. Pursuant to the Security Agreement, Borrower grants to Lender a security interest in all of Borrower's right, title and interest in and to that certain credit accommodation (the "Cryo-Trans Loan") provided by the Borrower to Cryo-Trans, Inc. ("Cryo-Trans"), including without limitation: (i) all documents executed and delivered in connection with the Cryo-Trans Loan, including, but not limited to, that certain Loan and Security Agreement, dated as of May 23, 1996, and as amended as of November 10, 1997, between Cryo-Trans and Borrower, the Cryo-Trans Promissory Note, dated the date hereof, executed by Cryo-Trans as maker thereof and payable to the order of Borrower, and any future or additional loan documents executed in connection with the Cryo-Trans Loan; and (ii) all collateral securing the repayment of the Cryo-Trans Loan, including without limitation, (A) the railcars (the "Railcars") as more fully described in attached Exhibit A, (B) those certain Railcar Utilization Agreements more fully described in attached Exhibit A, and any other Railcar Utilization Agreements hereafter executed with respect to the Railcars, as such agreements relate to the Railcars, or any substitution or replacement thereof, pursuant to which one or more Railcars are leased to, or made available for use by, any third party (collectively, the "Leases"), and (C) the payments and all other sums due now or hereafter under or with respect to any or all of the Leases or the Railcars, and all other proceeds of the foregoing.

IN WITNESS WHEREOF, each of the parties hereto has caused this MEMORANDUM OF SECURITY AGREEMENT to be executed by its duly authorized officer as of the date first above written.


