THIS MEMORANDUM OF LEASE OF RAILROAD EQUIPMENT made as of October 16, 1996 is intended to evidence Schedule No. 5 dated June 9, 1997 ("Schedule No. 5") to the Master Locomotive Lease Agreement dated as of May 1, 1995 (the "Lease") between HELM-ATLANTIC ASSOCIATES LIMITED PARTNERSHIP, a Delaware limited partnership (the "Lessor"), and UNION PACIFIC RAILROAD COMPANY, a Utah corporation (the "Lessee"), for the purpose of satisfying the requirements of recordation with the Surface Transportation Board of the Department of Transportation under Section 49 of U.S.C. 11301. 
