MEMORANDUM OF LESSOR'S SECURITY AGREEMENT
(Equipment Lot Bombardier 1997A-FH)

Memorandum of Lessor's Security Agreement, made and entered into on May 29, 1997, by and between FIRST SECURITY BANK, N.A., a national banking association, not in its individual capacity but solely as the Trustee (the "Lessor") and TRI-COUNTY METROPOLITAN TRANSPORTATION DISTRICT OF OREGON, a municipal corporation and a public body corporate and politic established under the laws of the State of Oregon (the "Lessee").

W I T N E S S E T H :

The undersigned have entered into that certain Lessor's Security Agreement (Equipment Lot Bombardier 1997A-FH), dated as of May 29, 1997, whereby the Lessor has granted, assigned, mortgaged and pledged to the Lessee a security interest in and lien upon all right, title and interest in, to and under the Lessor's Leasehold Interest (as defined below) and all proceeds thereof as security for the due and punctual performance and observance by the Lessor of (i) its obligations to transfer to the Lessee the Lessor's Leasehold Interest in certain light rail vehicles bearing the identification numbers as listed on Exhibit A attached hereto (the "Equipment"), if, as and when required under the Lease (as defined below) and (ii) all obligations of the Lessor under the Lessor's Security Agreement.


For purposes of this Memorandum, (a) "Leasehold Interest" means all of the Lessor's right, title and interest as lessee in, to and under the Head Lease (as hereinafter defined), and when used in relation to the Equipment refers to such right, title and interest with respect to the Equipment, (b) "Head Lease" means that certain Head Lease Agreement (Equipment Lot Bombardier 1997A-FH), dated as of May 29, 1997, between Lessee, as head lessor, and the Lessor, as head lessee, whereby the Lessee has agreed to lease to the Lessor and the Lessor has agreed to lease from the Lessee the Equipment, subject to the term defined in said Head Lease Agreement and (c) "Lease" means that certain Lease Agreement (Equipment Lot Bombardier 1997A-FH), dated as of May 29, 1997, between the parties hereto whereby the Lessor has agreed to lease to the Lessee and the Lessee has agreed to lease from the Lessor the Equipment, subject to the term defined in said Lease Agreement.

IN WITNESS WHEREOF, the parties hereto have each caused this Memorandum to be duly executed by their respective officers duly authorized as of the date and year first above written.
