
This Memorandum of Assignment Agreement is made and entered into as of February 12, 1999, by and between JAIX Leasing Company ("Assignor") and The CIT Group/Equipment Financing, Inc. ("Assignee") respecting the Sublease Assignment (the "Sublease Assignment") dated as of June 10, 1997 between Assignor and Assignee.

WITNESSETH:

1. Assignor, as Lessor, leased to Texas Utilities Electric Company ("Sublessee") one hundred fifteen (115) Aluminum AutoFlood Coal cars marked JAIX 99001 through JAIX 99115 inclusive, pursuant to a Railroad Equipment Lease dated as of August 1, 1998, and Rider 1 thereto, between Assignor and Sublessee (the "Sublease").
2. Assignor has agreed to assign to Assignee and Assignee has agreed to accept from Assignor the Sublease and the corresponding railcars which are subject of that Sublease.
3. Assignor and Assignee further acknowledge and affirm that this Memorandum of Assignment Agreement is not a summary of the provisions of the Sublease Assignment. Accordingly, Assignor and Assignee hereby agree that in the event of a conflict between this Memorandum of Assignment Agreement and the provisions of the Sublease Assignment, the provisions of the Sublease Assignment, shall control.
4. This Memorandum of Assignment Agreement may be executed by the parties hereto in any number of counterparts, and all counterparts taken together shall be deemed to constitute one instrument.

IN WITNESS WHEREOF, each of the parties hereto, pursuant to due corporate authority, has caused this Memorandum of Assignment Agreement to be duly executed in this corporate name by its officers, thereunto duly authorized, all as of the date first written.




