MEMORANDUM OF COLLATERAL ASSIGNMENT
OF RIGHTS UNDER RAILCAR LEASE AGREEMENT

THIS MEMORANDUM, dated as of March 30, 1998, is made by and between Charter Financial, Inc. a New York corporation with an office at 153 East 53rd Street, New York, New York 10022 ("Charter"), and SOUTHERN ILLINOIS RAILCAR COMPANY, an Illinois corporation, with its chief executive office and principal place of business at Executive Park Two, 505 Buckeye Drive, Troy, Illinois 62294 (the "Borrower").

Borrower and Charter hereby state the following:

1. Borrower and Charter are parties to that certain Full Recourse Assignment Agreement dated as of March 30, 1998 (the "Collateral Assignment"), whereby Borrower, to secure the payment and performance of any and all of Borrower's obligations to Charter, granted to Charter an unconditional assignment of the rights of the Borrower, as the assignee of the lessor, under Rider No. 11 dated October 21, 1998 to Leasing Agreement dated January ~~15~~₁₅, 199~~8~~₉₁ between Excel Rail Corporation and Vitro Corporativo S.A. de C.V. as lessee.
2. Said collateral assignment extends to the railcars, and only to the railcars, that are identified in Schedule 1 attached hereto.
3. Reference is made to the Collateral Assignment for a further description of the rights of Charter under the Collateral Assignment.
