The undersigned have entered into that certain Trust Indenture and Security Agreement (No. 47-NW) dated as of June 15, 1998, covering the railroad equipment listed in Schedule A hereto, pursuant to which equipment notes having a final maturity of January 15, 2015 or January 15, 2020, as the case may be, are being issued on the terms and conditions set forth in said Trust Indenture and Security Agreement, and wish to show for the public record the security interest of The First National Bank of Maryland, security trustee thereunder, of all of the right, title, and interest of TTX Lease 47-NW Trust, a Delaware trust, in and to (i) said equipment, the bills of sale and manufacturers' warranties in respect thereof, all improvements and additions now or hereafter made or affixed thereto (to the extent of the interest of The First National Bank of Maryland, not in its individual capacity but solely as trustee for TTX Lease 47-NW Trust, a Delaware trust, therein), and all cash and noncash proceeds therefrom and (ii) the Lease of Railroad Equipment dated as of June 15, 1998, between TTX Company and TTX Lease 47-NW Trust, in respect of such equipment, and all payments due and to become due thereunder, excluding, however, interests in certain rights, payments, and indemnities, as more fully set forth in said Trust Indenture and Security Agreement.
