

MEMORANDUM OF LEASE ASSIGNMENT

Memorandum of Lease Assignment, made and entered into on December 28, 1998, by and between First Security Bank, National Association, a national banking association, not individually but solely as Owner Trustee, as Lessor (the "*Lessor*") and Wilmington Trust Company, a Delaware banking corporation, not individually but solely as Security Trustee (the "*Security Trustee*").

WITNESSETH:

1. The Lessor and Virginia Electric and Power Company have entered into that certain Railcar Lease (the "*Lease*"), dated as of August 15, 1998, and Lease Supplement No. 4 (the "*Lease Supplement No. 4*") thereto, dated December 28, 1998, covering certain railroad rolling stock bearing road numbers as listed on Exhibit A attached hereto.
2. A memorandum of said Lease was recorded with the Surface Transportation Board on September 4, 1998 at 11:05 a.m. under recordation number 21624, pursuant to Section 11301 of Title 49 of the United States Code.
3. A memorandum of said Lease Supplement No. 4 was recorded with the Surface Transportation Board on December 23, 1998 at 10:50 a.m. under recordation number 21624-K, pursuant to Section 11301 of Title 49 of the United States Code.

The undersigned have entered into that certain Security Agreement-Trust Deed (the "*Security Agreement*"), dated as of August 15, 1998, and Security Agreement Supplement No. 4 (the "*Security Agreement Supplement No. 4*") thereto, dated December 28, 1998, pursuant to which First Security Bank, National Association, as Debtor, has assigned the aforesaid Lease, the aforesaid Lease Supplement No. 4, and the rents and other proceeds therefrom (with certain exceptions) to the Security Trustee.
5. A memorandum of said Security Agreement recorded with the Surface Transportation Board on September 4, 1998 at 11:05 a.m. under recordation number 21624-A, pursuant to Section 11301 of Title 49 of the United States Code.
6. A memorandum of said Security Agreement Supplement No. 4 was recorded with the Surface Transportation Board on December 23, 1998 at 10:50 a.m. under recordation number 21624-L, pursuant to Section 11301 of Title 49 of the United States Code.




