RELEASE AGREEMENT

This Release is made as of August 22, 1994, by Sequel Railcar Leasing Corporation, an Illinois corporation ("Lender") in favor of American Railcar Leasing Partners, an Illinois general partnership ("Lessor").

INTERSTATE COMMERCE COMMISSION

A. Pursuant to a Loan Agreement dated as of December 23, 1993, between Lender and Lessor, Lender has agreed to loan to Lessor monies (the "Loan") to finance various railcars. To secure payment of the Loan and certain other amounts, Lessor executed and delivered to Lender a Railcar Mortgage, Security Agreement and Assignment of Lease, dated as of December 23, 1993 (the "Security Agreement"), pursuant to which Lessor assigned, granted and pledged to Lender a security interest in the Railcars and the Lease and Lease Schedules (both as defined in the Security Agreement).

B. A Memorandum of Railcar Mortgage, Security Agreement and Assignment of Lease was filed for record in the office of the Interstate Commerce Commission in Washington, DC as follows:


C. Lessor has requested and Lender has agreed to release its security in the Railcars, namely: see Attachment 1 to this Release Agreement ("Released Equipment"), and the Lease insofar as it pertains to the Released Equipment and the Lease Schedule pertaining thereto.

NOW, THEREFORE, Lender agrees as follows:

1. With this Release Lender has repaid the loan to Lessor under the Loan Agreement. Accordingly, Lender hereby absolutely and unconditionally releases and discharges its security interest and any other rights, title or interest which it may have in the Released Equipment, the Lease insofar as it pertains to the Released Equipment and Schedule No. 1 to the Lease (together the "Released Lease").
2. Lender agrees that it will execute, acknowledge and deliver such further releases, termination statements, assignments and other further assurances pursuant to this Release Agreement as may be requested by Lessor in order to effectuate the release of the Released Equipment and Released Lease.


