MEMORANDUM OF LEASE ASSIGNMENT dated as of October 27, 1994, by FIRST SECURITY BANK OF UTAH, NATIONAL ASSOCIATION, not in its individual capacity but solely as trustee for TTX Lease 42-C Trust, a Utah trust, and FIRST SECURITY BANK OF IDAHO, NATIONAL ASSOCIATION, a national banking association.

The undersigned have entered into that certain Equipment Trust Agreement (No. 42-C), dated as of September 8, 1994, covering the railroad equipment listed in Schedule A thereto, pursuant to which equipment trust certificates having a final maturity of July 1, 2004 and January 1, 2011, are being issued on the terms and conditions set forth in said Equipment Trust Agreement.

A memorandum of said Equipment Trust Agreement has been recorded with the Interstate Commerce Commission pursuant to section 11303 of Title 49 of the United States Code, and assigned recordation number 18973-B.

The said Equipment Trust Agreement includes an assignment to First Security Bank of Idaho, National Association, security trustee thereunder, of all the right, title, and interest of First Security Bank of Utah, National Association, not in its individual capacity but solely as trustee for TTX Lease 42-C Trust in and to the Lease of Railroad Equipment (No. 42-C), dated as of September 8, 1994, between TTX Company and First Security Bank of Utah, National Association, not in its individual capacity but solely as trustee for TTX Lease 42-C Trust in respect of such equipment, and all payments due and to become due thereunder, excluding, however, interests in certain rights, payments, and indemnities, as more fully set forth in said Equipment Trust Agreement.



TTX Company and First Security Bank of Utah, National Association, not in its individual capacity but solely as trustee for TTX Lease 42-C Trust have entered into that certain Second Lease Supplement (No. 42-C), dated as of October 27, 1994, including in the said Lease of Railroad Equipment the railroad equipment listed in Schedule A hereto.

The undersigned have entered into that certain Second Equipment Trust Agreement Supplement (No. 42-C), dated as of October 27, 1994, and wish to show for the public record the assignment thereunder to First Security Bank of Idaho, National Association, security trustee under the said Equipment Trust Agreement, of all of the right, title, and interest of First Security Bank of Utah, National Association, not in its individual capacity but solely as trustee for TTX Lease 42-C Trust in and to the said Second Lease Supplement, and all payments due and to become due thereunder, excluding, however, interests in certain rights, payments, and indemnities, as more fully set forth in said Equipment Trust Agreement.


