**MEMORANDUM OF TRUST INDENTURE SUPPLEMENT NO. 1
(BN 1994-F)**

Memorandum of Trust Indenture Supplement No. 1, made and entered into as of September 15, 1994 among Wilmington Trust Company, as Owner Trustee, a Delaware banking corporation ("*Owner Trustee*") and First Security Bank of Utah, National Association, as Indenture Trustee, a national banking association ("*Indenture Trustee*").

WITNESSETH:

1. The undersigned have entered into that certain Trust Indenture and Security Agreement (BN 1994-F) (the "*Trust Indenture*"), dated as of September 15, 1994, by which the Owner Trustee has granted a security interest to the Indenture Trustee in order to secure the Owner Trustee's performance of certain obligations as described in the Trust Indenture.
2. A memorandum of said Trust Indenture is being recorded with the Interstate Commerce Commission concurrently herewith pursuant to Section 11303 of Title 49 of the United States Code.
3. The undersigned have entered into that certain Trust Indenture Supplement No. 1 (BN 1994-F), dated September 29, 1994, relating to the above-described Trust Indenture and extending the Owner Trustee's grant of a security interest therein to locomotives and railcars bearing reporting marks as listed on Exhibit A attached hereto.


