PARTIAL RELEASE OF RAILCAR LIEN

KNOW ALL MEN BY THESE PRESENTS THAT:

WHEREAS, TEMCO CORPORATION, an Illinois corporation, ("TEMCO") has heretofore executed and delivered its Railcar Mortgage and Security Agreement dated as of February 10, 1996 (the "Railcar Security Agreement") to LASALLE NORTHWEST NATIONAL BANK, a national banking association (the "Bank"); and

WHEREAS, the Railcar Security Agreement was duly recorded and filed with the Interstate Commerce Commission pursuant to 49 U.S.C. § 11303 on February 17, 1996, under Recordation Number 19248; and

WHEREAS, TEMCO has requested the Bank to release from the lien of the Railcar Security Agreement certain property hereinafter particularly described;

NOW, THEREFORE, the Bank, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, receipt whereof is hereby acknowledged, does hereby **RELEASE, REMISE, CONVEY AND QUITCLAIM** unto TEMCO, its successors and assigns, all of the right, title, lien, interest, claim or demand whatsoever which the Bank has or may have acquired under, through or by virtue of the Railcar Security Agreement in and to the property described in Appendix A hereto.

THIS INSTRUMENT is executed upon the express condition that nothing herein contained shall be construed to release from the lien of the Railcar Security Agreement, or to impair said lien upon any property subject thereto, except the property hereinabove specially described, and nothing herein contained shall be construed as a release or waiver of any obligation of TEMCO to the Bank.
