MEMORANDUM OF LEASE AGREEMENT

THIS MEMORANDUM OF LEASE AGREEMENT is made and entered into as of June 28, 1995 between ASEA BROWN BOVERI AG & CO. LEASING KG, a Kommanditgesellschaft established and existing under the laws of the Federal Republic of Germany ("Lessor"), and TRIBOROUGH BRIDGE AND TUNNEL AUTHORITY, a body corporate and politic constituting a public benefit corporation created and existing pursuant to the laws of the State of New York ("Lessee").

WITNESSETH:

1. Pursuant to the Lease Agreement dated as of December 21, 1994 (the "Lease"), and a Lease Supplement dated as of June 28, 1995, Lessor has leased unto Lessee certain M-6 Rail Cars manufactured by Morrison Knudsen Company, Inc., bearing serial numbers as set forth on Schedule A attached hereto and incorporated herein (the "Items of Equipment"). Capitalized terms used and not otherwise defined herein shall have the meanings ascribed to them in the Lease.
2. The Lease has taken effect for a basic Lease Term for the Items of Equipment commencing on June 28, 1995 or, if such date is not a Banking Day, then the next succeeding Banking Day, and to end on December 28, 2011 or, if such date is not a Banking Day, then the next succeeding Banking Day.
3. Pursuant to the Lease, Lessee has a right of first refusal to purchase the Equipment upon the terms and conditions set forth in the Lease.
