

**MEMORANDUM OF TRUST INDENTURE AND SECURITY AGREEMENT
(BN 1995-C)**

Memorandum of Trust Indenture and Security Agreement, made and entered into as of June 29, 1995 by and between Wilmington Trust Company, as Owner Trustee, a Delaware banking corporation ("*Owner Trustee*"), and First Security Bank of Utah, National Association, as Indenture Trustee, a national banking association ("*Indenture Trustee*").

WITNESSETH:

The undersigned have entered into that certain Trust Indenture and Security Agreement (BN 1995-C) (the "*Trust Indenture*"), dated as of June 15, 1995, by which the Owner Trustee has granted a security interest in certain locomotives and aluminum rotary gondola coal cars bearing reporting marks as listed on Exhibit A attached hereto to the Indenture Trustee in order to secure the Owner Trustee's performance of its obligations as described in the Trust Indenture.




