MEMORANDUM OF LOAN AND SECURITY AGREEMENT
(Equipment Lot FU)

Memorandum of Loan and Security Agreement (Equipment Lot FU), dated as of October 3, 1995, by and between Shawmut Bank Connecticut, National Association, a national banking association, and Frank W. McDonald, Jr., not in their individual capacity but solely as Owner Trustees ("*Lessor*"), and Utrecht-America Finance Co., a Delaware corporation, as Lender (the "*Lender*").

WITNESSETH:

The parties hereto are entering into that certain Loan and Security Agreement (Equipment Lot FU), dated as of October 3, 1995, whereby Lessor agrees to grant to Lender as security for Lessor's performance of its obligations described in said Loan and Security Agreement (Equipment Lot FU) a first priority security interest in, mortgage lien on, and pledge of, all of the Lessor's right, title and interest in, to and under the collateral listed on Exhibit A attached hereto (the "*Collateral*").

This Memorandum may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts shall together constitute but one and the same instrument.

IN WITNESS WHEREOF, the parties hereto have each caused this Memorandum to be duly executed by their respective officers duly authorized as of the date and year first above written.


